Action: 6.02 Ratification of Results of Proposition No. 2 - Expenditure of Capital Reserve Fund  
Recommendation to approve the following resolution:

"RESOLVED, that the results of the school district election held on May 17, 2022 for Proposition No. 2, School District Budget Vote for 2022-2023, which reads: SHALL the Board of Education of the Northport-East Northport Union Free School District be authorized to expend \$5,694,660 for the purpose of performing the following projects: (1) District-wide roof replacement; (2) District-wide HVAC renovations and/or reconstruction; (3) District-wide asbestos abatement; and (4) Bleacher replacement and/or reconstruction, all of the foregoing to include all labor, materials, equipment, apparatus and incidental costs related thereto. The total cost of the four projects is \$ 5,694,660 and will be funded from the Capital Reserve Fund established in 2012 (\$536,290), the Capital Reserve Fund established in 2018 (\$3,158,370) and the Capital Reserve Fund established in 2021 (\$2,000,000.00), is declared approved by a count of 2,983 Yes; 958 No"
