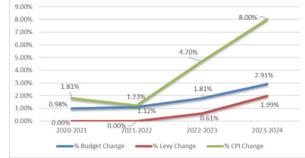

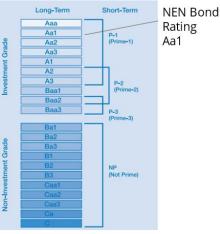

Tax Levy within the levy limit. Requires a simple majority for voter approval.

State Aid budget to budget increase estimated to be \$700k. This is based off of the expected increases to aid that has not yet been approved due to the late NYS budget adoption. Assigned Fund Balance is above the historical average but was reduced by \$500k. Other Revenue increase is primarily due to the \$1 million increase to the budgeted interest earnings due to expected continued

higher interest rates.

### Discussion





In light of there being no changes to the State Aid or Transportation estimates between Draft Budget #3 and tonight's Final Draft Budget, there are two options to consider for tonight's resolution:

- **Option One**: Approve resolution with a budget of \$187,932,561, representing a 2.33% increase in the levy
- Option Two: Reduce the levy to a lower number amenable to the Board

If the Board elects Option Two, the administration recommends an increase to the fund balance transfer that was lowered due to revised interest earnings projections. This will allow for maximum flexibility when final State Aid numbers and the transportation contract are finalized.
