

Major Revenue Items

- Tax Levywithin the levy limit. Requires a simple majority for voter approval. State Aid The state budget was delayed and not approved until after our budget adoption. The final state budget included a \$20,529,188 increase for NEN which is \$278K less than what was budgeted. The district plans on submitting expense reimbursements for capital projects that may reduce that revenue shortfall.
- Assigned Fund Balance is above the historical average but was reduced by \$500k. Other Revenueincrease is primarily due to the \$1 million increase to the budgeted interest earnings due to expected continued higher interest rates. 4




PROPOSITION NO. 1

RESOLVED, that the Annual School District Budget for the 2022025 School Year in the amount of \$187,932,561 and the necessary taxes therefore be approved.

PROPOSITION NO. 2

SHALL the Board of Education of the Northportfast Northport Union Free School District be authorized to expend a sum not to exceed \$1,000,000.00 from the 2021 Capital Reserve Fund as established on May 18, 2021 for the purpose of performing Distribute roof replacements and District-wide HVAC reconstruction/renovations and including all labor, materials, equipment, apparatus and incidental cost related thereto? Since the funds to be expended hereunder are from the Capital Reserve Funds, approval of this Proposition will not require a tax levy upon the real property of the School District.

Name Comment

- Lenny Olignyk Stated that half his group agree with the budget and half do not. Most of the budget is due to inflation. The only thing he would like to see in the budget is insurances that the school will start to repurpose the empty buildings and move the bus depot to Bellerose Avenue School.
- Christina Karman Stated she felt the budget book was less transparent and didn't show past budget amounts. There are no cuts from the high school or the middle schools, just the elementary schools.
- Michelle Coggins Asked what the difference is in sending a child to private school or variance to another school. Stated that the District needs to rethink the bus availability. Asked when the next projection of enrollment would be done.

Dr. Moyer stated that the enrollment tracking has been pretty close. The last study was done this past summer and typically studies are done every five to seven years. In regards to the busing, it is dictated by

law. Dr. Moyer stated that Lenny sent an email with some things he talked about tonight and he believes there are some good ideas. The transportation setup needs to be looked at and opportunities for expanding partnerships for the utilization of space.

Dr. Licopoli stated that the financial committee will be re-engaged this year.







1 - Replace the three diploma types with one diploma with the option to add seals and endorsements.

"By moving to a one-diploma system with optional seals and endorsements, a NYS high school diploma would reflect rigorous standards while allowing students to demonstrate their unique interests and accomplishments."



CREDIT AND PROGRAM REQUIREMENTS

2 - Diploma credit requirements MUST include:

- Civic responsibility
- Cultural competence
- Financial literacy education
- Fine and performing arts
- Science, technology, engineering, and mathematics (STEM) credits
- Writing, including writing skills for reaworld scenarios

3 - Ensure access to career and technical education (CTE), including internships and work-based learning opportunities.

4 - Move to a model that organizes credit requirements, including content area credit requirements into larger categories (ex. Math & science as a "STEM" category). This model must:

- Allow for a proficiency-based model to award credit
- Allow local districts to offer unique options for students to earn course credit



DIPLOMA ASSESSMENT REQUIREMENTS

5 - Reduce and/or modify diploma assessment requirements to allow more assessment options. Such options must:

- Align with Culturally Responsive Sustaining Education Framework
- Allow students to demonstrate competency in multiple ways
- Assess the attributes included in the portrait of a graduate
- Be available to all students
- Include writing
- Measure higher order thinking
- Meet the needs of all learners, including ELLs, SWD, & other underserved pop.
- Provide student choice in the options including performancebased assessments, capstone projects, experiential learning

6 - Create statedeveloped rubrics for any performancbased assessments allowed as an option to satisfy the diploma assessment requirements.



7 - Create more specific, tailored graduation requirements to address the unique circumstances of certain groups of students (non-compulsory age students, newcomer students, refugee students).

8 - Provide exemptions from diploma assessment requirements for:

- Students with significant cognitive disabilities
- Major life events and extenuating circumstances (medical conditions, death of a family member, trauma prior to required exam)

9 - Pursue regulatory changes to allow the discretion to confer high school degrees posthumously.



10 - Require all NYS teacher preparation programs to provide instruction in CR-SE practices and pedagogy.

11 - Require that professional development plans include CRSE practices.

12 - Review and revise the NYS learning standards to better align with college and career expectations; emphasize higher-order thinking skills; and use a CR-SE, diversity, equity, and inclusion lens in all subject areas.
